ANHANG: Definition der IFRA-Klassen

IFRA-Klasse	Arten von Endprodukten
1	Lip products of all types (solid and liquid lipsticks, balms, etc.) Children's toys
2	Body sprays (including body mist) Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne, etc.)
3	Body and face paint (for children and adults) Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, etc.) including eye care and moisturizer Facial make up and foundation Facial masks for face and around the eyes Make-up remover for face and eyes Nose pore strips Wipes or refreshing tissues for face, neck, hands, body
4	Products related to fine fragrance: Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, etc.) Fragranced bracelets Aftershaves of all types (except creams and balms) Ingredients of perfume kits and fragrance mixtures Scent pads, foil packs Scent strips for hydroalcoholic products
5A	All powders and talc (excluding baby powders and talc) Body creams, oils, lotions of all types Foot care products (creams and powders) Insect repellent (intended to be applied to the skin)
5B	Facial moisturizers and creams (including care products for beard and mustache) Facial toner

7A	Rinse off products applied to hair with hand contact: Hair permanent or other chemical treatments (rinse-off) (e.g. relaxers), including rinse-off hair dyes

8	Baby wipes Intimate deodorant spray Intimate wipes Tampons Toilet paper (wet)

10A	Household care products with hand contact (excluding aerosols/sprays): Hand wash laundry detergent (including concentrates) Laundry pre-treatment of all types Hand dishwashing detergent (including concentrates) Hard surface cleaners of all types Machine laundry detergents with skin contact Fabric softeners of all types excluding fabric softener sheets Household cleaning products, other types Floor wax Fragranced oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners, etc. Ironing water
10B	Household care aerosol/spray products: Animal sprays - applied to animals of all types Air freshener sprays, manual, including aerosol and pump Aerosol/spray insecticides
11A	Feminine hygiene conventional pads, liners, interlabial pads Diapers (baby and adult) Adult incontinence pant, pad Toilet paper (dry)
