## ANHANG: Definition der IFRA-Klassen

IFRA-Klasse	Arten von Endprodukten
<b>1</b>	Lip products of all types (solid and liquid lipsticks, balms, etc.) Children's toys
<b>2</b>	Body sprays (including body mist) Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne, etc.)
<b>3</b>	Body and face paint (for children and adults) Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, etc.) including eye care and moisturizer Facial make up and foundation Facial masks for face and around the eyes Make-up remover for face and eyes Nose pore strips Wipes or refreshing tissues for face, neck, hands, body
<b>4</b>	Products related to fine fragrance: Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, etc.) Fragranced bracelets Aftershaves of all types (except creams and balms) Ingredients of perfume kits and fragrance mixtures Scent pads, foil packs Scent strips for hydroalcoholic products
<b>5A</b>	All powders and talc (excluding baby powders and talc) Body creams, oils, lotions of all types Foot care products (creams and powders) Insect repellent (intended to be applied to the skin)
<b>5B</b>	Facial moisturizers and creams (including care products for beard and mustache) Facial toner
<b>5C</b>	Hand cream Hand sanitizers Nail care products including cuticle creams, nail lacquer remover, etc.
<b>5D</b>	Baby cream/lotion, baby oil, baby powders and talc
<b>6</b>	Products with oral and lip exposure: Toothpaste Mouthwash, including breath sprays Toothpowder, strips, mouthwash tablets
<b>7A</b>	Rinse off products applied to hair with hand contact: Hair permanent or other chemical treatments (rinse-off) (e.g. relaxers), including rinse-off hair dyes

<b>7B</b>	Hair deodorizer, hair perfume Hair permanent or other hair chemical treatments (leave-on) (e.g. relaxers), including leave-on hair dyes Hair sprays of all types (pumps, aerosol sprays, etc.) Hair styling aids non sprays (mousse, gels, leave-on conditioners) Shampoo-Dry (waterless shampoo)
<b>8</b>	Baby wipes Intimate deodorant spray Intimate wipes Tampons Toilet paper (wet)
<b>9</b>	Rinse off products with body and hand exposure: Bar soap Shampoo of all types Cleanser for face Conditioner Liquid soap Body washes and shower gels of all types Baby wash, bath, shampoo Bath gels, foams, mousses, salts, oils and other products added to bathwater Foot care products (feet are placed in a bath for soaking) Shaving creams of all types (stick, gels, foams, etc.) All depilatories (including facial) and waxes for mechanical hair removal Pet Shampoo
<b>10A</b>	Household care products with hand contact (excluding aerosols/sprays): Hand wash laundry detergent (including concentrates) Laundry pre-treatment of all types Hand dishwashing detergent (including concentrates) Hard surface cleaners of all types Machine laundry detergents with skin contact Fabric softeners of all types excluding fabric softener sheets Household cleaning products, other types Floor wax Fragranced oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners, etc. Ironing water
<b>10B</b>	Household care aerosol/spray products: Animal sprays - applied to animals of all types Air freshener sprays, manual, including aerosol and pump Aerosol/spray insecticides
<b>11A</b>	Feminine hygiene conventional pads, liners, interlabial pads Diapers (baby and adult) Adult incontinence pant, pad Toilet paper (dry)

<b>11B</b>	Facial masks (paper/protective) e.g. surgical masks not used as medical device Facial tissues (dry tissues) Fertilizers, solid (pellet or powder) Napkins Paper towels Pillow spray Scented socks, gloves Tights with moisturizers
<b>12</b>	Air delivery systems Automated air fresheners and fragrancing of all types Candles of all types (including encased) Cat litter Deodorizers/maskers not intended for skin contact Dishwash detergent and deodorizers for machine wash Dry sheets and fabric softener sheets Fuels Insecticides (excluding aerosols/sprays) Joss sticks or incense sticks Laundry detergents for machine wash with minimal skin contact Paints Plastic articles (excluding toys) Rim blocks (Toilet) Scent beads Shoe polishes Toilet gel
