ANNEX: Definition of IFRA classes

1	Lip products of all types (solid and liquid lipsticks, balms, etc.) Children's toys

3	Body and face paint (for children and adults) Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, etc.) including eye care and moisturizer Facial make up and foundation Facial masks for face and around the eyes Make-up remover for face and eyes Nose pore strips Wipes or refreshing tissues for face, neck, hands, body
